Course Description	The purpose of this course is to introduce you to a set of topics and policy issues pertaining to the macroeconomy, and to provide you with the theoretical tools and foundations to understand them. The course will examine the problems of inflation, unemployment, and government deficits; consumption and savings in closed and open economy settings, credit market imperfections; as well as monetary policy issues, focusing on the role of expectations.
Textbook	There is no required textbook for this course. The slides and problem sets posted on the course web page should give you enough material to work with. Grading scheme

Let M_{midterm} denote your mark on the midterm, and M_{final} your mark on the final exam. M_{midterm} and M_{final} are numbers between 0 and 100. The overall mark, or numerical grade, denoted W , is given by:

$$W = \frac{40}{100}M_{\text{midterm}} + \frac{60}{100}M_{\text{final}}.$$

The letter grade, denoted as G , is given by:

$$G = \begin{cases} \text{A+} & \text{if } W \geq 95 \\ \text{A} & \text{if } W \in [85, 95) \\ \text{B+} & \text{if } W \in [75, 85) \\ \text{B} & \text{if } W \in [70, 75) \\ \text{C+} & \text{if } W \in [65, 70) \\ \text{C} & \text{if } W \in [55, 65) \\ \text{D+} & \text{if } W \in [50, 55) \\ \text{D} & \text{if } W \in [45, 50) \\ \text{E} & \text{if } W \in [40, 45) \\ \text{F} & \text{if } W < 40 \end{cases}.$$

Prerequisites AP/ECON 2400 3.0 (Intermediate Macroeconomic Theory I) or equivalent. I also strongly recommend that you review the material of AP/ECON 1530 3.0 and AP/ECON 1540 3.0 (Introductory Mathematical Economics I and II).
